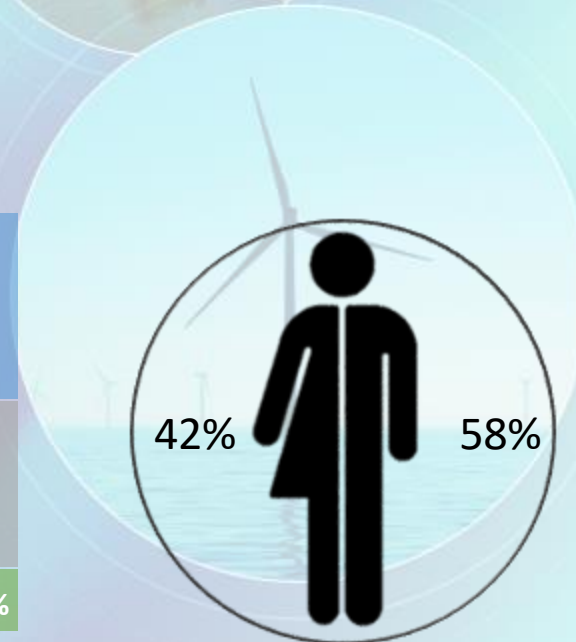
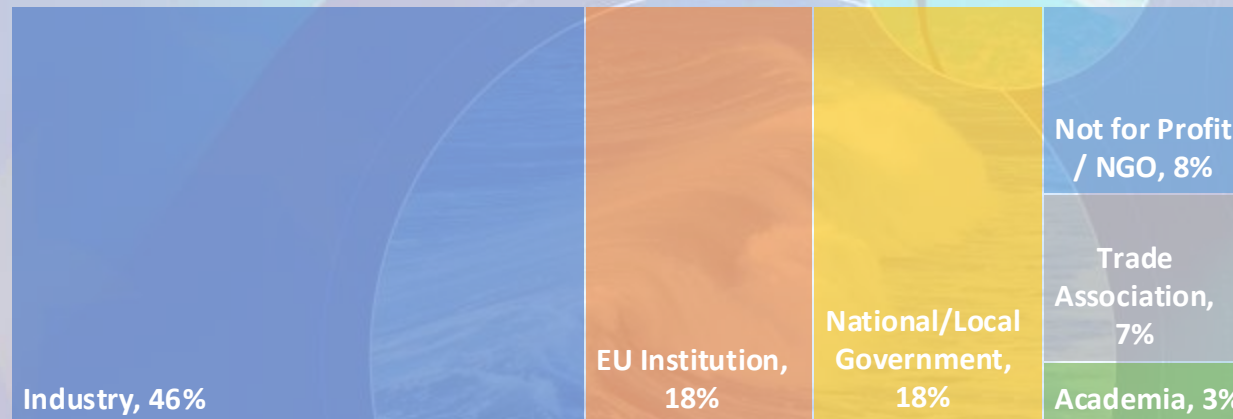
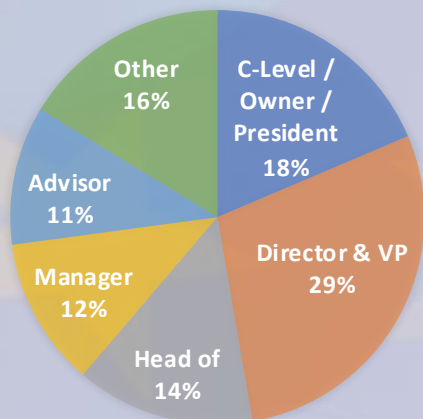


# Overview
